Vaccination Policy

Pet City Resort requires proof of annual vaccinations before your pet can board with us. You will be required to show documentation from your veterinarian showing that your pet's vaccinations are current. Your vet can also fax us a copy of your pet's vaccination records to 513-874-9274. If you are unable to provide proof of vaccinations we will be unable to board your pet at this time.

Required Vaccines: Dogs: DHPP (Distemper, Parvovirus), Bordetella, Rabies

Cats: Feline Distemper (FVRCP), Rabies

Medications

We will gladly administer your pet's medications during their stay with us. Please notify the receptionist of any medications, the dosage and how many times per day to administer. Administering medications is done so at \$1.00 per day. Insulin injections require a signed waiver and are given at \$5.00 a day.

In Case of Emergency (please select one option)

We closely monitor each pet's food intake, eliminations and daily activities and any problems are noted and reported immediately. If your pet is in need of medical attention, we will call the emergency number listed on the boarding form regarding your pet's symptoms. Your veterinarian will also be contacted and we will proceed per their instructions. If neither you or the emergency contact can be reached, please indicate how you would like us to proceed (**please select one option**):

- Should **any medical condition arise**, including non-life threatening situations, and neither the emergency contact or I can be reached, it is agreed that Pet City Resort or its selected agent can and will make any needed decision concerning medical treatment at my designated veterinarian or if my vet is unavailable, at the veterinarian of Pet City Resort's choice up to \$ _____ amount.
- Should **a potentially life-threatening situation arise**, and neither the emergency contact or I can be reached, it is agreed that Pet City Resort or its selected agent can and will make any needed decision concerning medical treatment at my designated veterinarian or if my vet is unavailable, at the veterinarian of their choice up to \$ _____ amount. We will continue to try to reach the emergency numbers in case a non-life threatening situation arises as well.
- Should any medical condition arise **DO NOT TAKE ANY ACTION** until specific authorization is given regardless of the situation. Please keep in mind that we cannot help your pet in the event of an emergency if you select this option.

Flea Protection

These are the only types of flea prevention from your veterinarian that we will accept. Any other type will not be recognized. Pet City Resort maintains the highest standards of cleanliness and will not be held responsible for any parasite problem that may arise because of improper flea prevention. If your pet is found to have fleas, we will contact the owner and will give a flea bath at the owner's expense.

Pet City Resort includes potty breaks every 3 hours, with the option of additional potty breaks and playtimes, for every guest in our care. Your pet will be taken outside in the designated play area for these activities, weather permitting for the playtimes. If you would prefer your pet stay indoors, or if your pet has a history of fence jumping, please indicate that you would like the playtimes indoors or to keep your pet on a leash at all times when outdoors in the designated fenced in play area. Your pet will never be mixed with any other pet while outdoors. Only families at a time permitted in outdoor play area.

____ Please keep my pet on a leash while in designated privacy fenced in play area, due to a history of fence jumping.

____ I authorize employees of Pet City Resort to take my pet(s) outdoors in the designated fenced in play area for their playtimes and potty breaks. I release employees and owners of Pet City Resort from any and all liability should my pet(s) escape and/or get injured during their time outdoors.

Walk/Hike Waiver (complete only if your pet will be going on our nature hike / run)

I, _____, understand that my pet(s) _____ will be kept on their leash, provided by the owner, at all times. I release employees and owners of Pet City Resort from any and all liability should my pet(s) escape and/or get injured during their time outdoors or during transport. I agree that my pet may ride in a vehicle with an employee or owner of Pet City Resort from 9474 Princeton Glendale Road, West Chester Ohio to the Upper Mill Creek Conservation Corridor located on the corner of SR747 and Port Union Road.

Pet City Resort agrees to exercise due and reasonable care against illness, injury, and escape of my pet. However, while on the premises, Pet City Resort will not be held responsible for any unforeseen circumstances affected by the behavior or health problems of my pet. The services Pet City Resort provides are done so without liability for loss or damage from disease, running away, and from injury or damage done so by your pet to people, other animals or property, or other unavoidable causes. Due diligence and care has been exercised.

You are welcome to bring toys and blankets from home. Please do not bring irreplaceable items. Pet City Resort is not responsible for damaged or misplaced items, or damage caused to your pet by swallowing or ingesting items or parts of items left with us.

No pet will be released until all charges are paid in full or other arrangements satisfactory to our kennel have been made. I agree to notify Pet City Resort in advance if there is any change in my pet's pick up date. Should my pet remain unclaimed after the pick up date, which I have indicated, I understand that a written notice will be mailed to the address on my account. Ten days after the written notice and reasonable attempts to contact me have been made, the pet will be considered abandoned and may be, according to law, disposed or destroyed as the Pet City Resort deems best. It's further understood that such action will not relieve me from financial obligations.
